## Greater Dandenong City Council Summary of Initial and Biannual Personal Interests Returns



Council Officers and Delegated Committee Members - September 2024 - February 2025

Under section 134 of the *Local Government Act 2020* a specified person must lodge a biannual personal interests return with the Chief Executive Officer containing matters prescribed by the *Local Government (Governance and Integrity) Regulations 2020*. Biannual personal interests returns must be lodged by specified persons twice yearly by the end of each prescribed period. The prescribed periods are from 1-31 March and 1-30 September each year. A specified person includes the Chief Executive Officer, a member of a delegated committee or a nominated officer (a member of Council staff who is nominated by the Chief Executive Officer because of their role or who has a statutory or delegated power, duty or function).

Further, the Chief Executive Officer nominated additional staff positions on 1 March 2024. These new nominated positions are included in this list (as are any new staff employed after 1 March 2024). Under section 133 of the *Local Government Act 2020* a specified person (which includes nominated officers by the Chief Executive Officer) must lodge an initial personal interests return with the Chief Executive Officer containing matters prescribed by the *Local Government (Governance and Integrity) Regulations 2020*.

Under section 135 of the *Local Government Act 2020*, the Chief Executive Officer must prepare a summary of the personal interests information disclosed in the last personal interests return lodged. This summary must be made available on Council's Internet site and must be available for inspection at Council's office.

The following provides the categories under which all details must be disclosed on a personal interests return form as required under section 8 of the *Local Government (Governance and Integrity) Regulations 2020.* This also provides a key to the following summary table.

- 1. Any corporation of which the specified person is a director or member of the governing body.
- 2. Any unincorporated association in which the specified person is a member and performs a leadership
- 3. Any business partnership or joint venture of which the specified person is a member.
- 4. Any trust that the specified person is a trustee or a beneficiary of.
- 5. Any paid employment of the specified person (other than employment with Council) limits apply.
- 6. Any person or body for whom the specified person is currently or has acted as, a consultant, contractor or agent.
- 7. Any land the specified person owns or has a beneficial interest in within the municipality or an adjoining municipality.
- 8. Any shares the specified person owns or has have a beneficial interest in limits apply.
- 9. Any company which the specified person solely, or jointly with any family members, holds a controlling interest
- 10. Any personal debt of the specified person exceeding \$10,000 other than with a banking or financial institution.
- 11. Any gift(s) received by the Councillor of a value equal to or exceeding \$500 including gifts in the form of goods or services and multiple gifts that have a combined value equal to or exceeding \$500.
- 12. Any other interests the specified person has decided to disclose which may give rise to a general or material conflict of interest.

## **Initial Returns**

- 1. Any corporation of which the specified person is a director or member of the governing body.
- 2. Any unincorporated association in which the specified person is a member and performs a leadership role.
- 3. Any business partnership or joint venture of which the specified person is a member.
- 4. Any trust that the specified person is a trustee or a beneficiary of.
- 5. Any paid employment of the specified person (other than employment with Council) limits apply.
- 6. Any person or body for whom the specified person is currently or has acted as, a consultant, contractor or agent.
- 7. Any land the specified person owns or has a beneficial interest in within the municipality or an adjoining municipality.
