## 2 SWEARING IN CEREMONY

### 2.1 Oaths or Affirmation of Office/Councillor Code of Conduct Declarations

In order for the Councillors-elect to assume the responsibilities of office, Section 30(1) of the *Local Government Act 2020* and Part 2 of the *Oaths and Affirmations Act 2018* requires that an Oath or Affirmation of Office is taken before the Chief Executive Officer of Greater Dandenong City Council.

Oaths or Affirmations of Office are taken as follows:

#### **OATH**

"I ..... swear under God that I will undertake the duties of the office of Councillor in the best interests of the municipal community. I will abide by the Model Councillor Code of Conduct and uphold the standards of conduct set out in the Model Councillor Code of Conduct.  
I will faithfully and impartially carry out and exercise the functions, powers, authorities and discretions vested in me under the *Local Government Act 2020* and any other Act to the best of my skill and judgement."

Or

#### **AFFIRMATION**

"I ..... will undertake the duties of the office of Councillor in the best interests of the municipal community. I will abide by the Model Councillor Code of Conduct and uphold the standards of conduct set out in the Model Councillor Code of Conduct.  
I will faithfully and impartially carry out and exercise the functions, powers, authorities and discretions vested in me under the *Local Government Act 2020* and any other Act to the best of my skill and judgement."
